Meeting Summary Planning Unit Little Spokane River – Middle Spokane River Local Watershed Plan September 27, 2000

Stan Miller called the meeting to order at 10:10 am.

The County is in the final stage of developing the contract with Golder Associates. The final agreement should be in place by the next meeting.

The committee was informed of the decision to use the County Public Works Departments Public Information person, Laura Rumpler, as a facilitator. Ms. Rumpler has been working with the Planning Commission on the Comp Plan. Having her do this programs facilitation will improve communication between county staff and the Facilitator. The County will still need to find clerical support to operate the program effectively.

The work plan developed earlier and incorporated into the consultant scope of work calls for the Planning Unit to produce a number of products that will form the basis of Golder's work. While progress is being made on all of these area, there are many details that need to be addressed. Most of the mapping work for land use, geology soils and so on is on track. Spokane County has planning intern working to help build the necessary detail into the Stevens and Pend Oreille County mapping. Water use data for the major purveyors is fairly well complete; we need to finalize a final data tabulation in a consistent format. There is still considerable work to be done on the smaller public water supply systems. Current work is focusing on prioritizing the hundreds of facilities into those needed and those desired. Ecology has started developing Water Rights and Claims data and the associated water use.

Rick Noll reported that the Little Spokane River Technical Committee has identified the following items to be priorities for the their program. These are:

Conduct a riparian area study Conduct a study of invertebrate populations and diversity Conduct a nitrate study on the River Conduct a fish type and distribution study Continue collection of flow data at established sites

The committee discussed the possibility of scheduling a public meeting within the next month or two. The consensus was that there was not enough new information, since the spring meeting, to warrant a meeting. A better time would be to wait until there are some "draft" results from the consultants work. It was suggested that we have watershed planning materials available at the Comp Plan Hearings.

The group decided to continue having meetings on the third Wednesday of each month at the SCCD Conference Room. The next meeting was scheduled for Oct. 18th.
