Introductions and Meeting Summary: Susan Gulick called the meeting to order. Committee members and guests introduced themselves. The meeting summary for May 16, 2007 was reviewed and approved with one correction, West Branch Little Spokane River Committee Reports was listed as *no update*, rather than there was no meeting since the last Planning meeting so there was nothing new to report.

COMMITTEE REPORTS:

<u>West Branch Little Spokane River:</u> Bill Harmon and Greg Sweeney reported that the sub committee met and worked on the grant to submit it to the Planning Unit before submitting it to the Department of Ecology.

Middle Spokane Instream Flow Report: Reanette reported that the WRIA54/55/57 Watershed Planning Unit meeting being held on June 27, 2007 at Airway Heights, Community Bldg. has been changed to 10 a.m. This will be a "kick off" meeting to set the scope of what the Instream Flow Committee will do. Reanette will send out a list of people who have signed up for the committee and ask for additional committee members.

<u>Conservation</u>: Reanette reported the Regional Committee has decided to have public irrigation classes next year. Members have discussed possible ways to prepare a list of contractors able to install efficient sprinkler systems for distribution to the public. Ty Wick reported that the elementary school level virtual tour field trips have been reviewed and completed and the middle school field trip is almost complete.

Rob Lindsay indicated he had heard City of Spokane representatives were meeting with Idaho officials in Coeur d'Alene to discuss bi-state water management issues.

Mike Lithgow stated he had attended a Washington Water Law Conference and one of the topics was on adjudication and adjudication light and how they work.

Sara Hunt reported she would be attending a Reclaimed Water Workshop on June 12, 2007.
